At the same time, we received an invitation to submit a full application for a UNTF- ACT call due 16 June. The requirements look very similar. Are we eligible to apply for both?  In the CSO Criteria, the call indicates that the CSO need to be a women's	An organization/ network is eligible to apply for both, but they can only receive funding from one source (either from UNTF or UN Women East and Southern Africa) since it is from the same donor. AS UN Women we are also trying to ensure that more WROs have access to the funding meaning one organization/WRO can only get funding from one funding source.  In terms of eligibility, as per the Call for Proposals, this call is targeting women's rights organizations, networks,	
	rights organization led by women or young women in all their diversity, If the organization is a human rights organization which means women's rights is part of its core mandate and the gender/women's rights focal person is a young woman who will oversee this project, does that qualify as eligibility?  Also, can you please clarify Component 1 under Outcome 1.	or coalitions, with organizations led by women or young women in all their diversity <b>considered as an asset</b> . This means that while it is not a requirement for the organization to be led by a woman, it is considered an asset if the head/ Director/CEO of the organization is a woman or a young woman.  Component 1 is more on institutional strengthening and sub-regional collaboration to address backlash.

UN Women can only sign a partnership agreement with a single entity, so when a network or group of organizations apply, there needs to be a primary applicant. There is no limit in terms of the number of submissions in which an organization is included as a member, although there

WROs/networks/coalitions operating at multicountry, sub-regional or regional level in East and Southern Africa are eligible to apply for this call (organizations with programmatic focus on only one country are not eligible). We have a separate process for partnerships with private sector companies <sup>2</sup>

Component 1 is more institutional strengthening and subregional collaboration to address backlash. While component 2 is more about cross-movement connectivity and collaboration. The key is how we connect different movements (linking organizations working on women's rights broadly with organizations of persons with disabilities or adolescent-led organizations, organizations as part of work on strengthening resilience. Component 2 is also about documenting experience of work across movements.

Resources for the programme is a partnership between UN Women and EU globally under the GBV Action Coalition complementing existing resources and investments at the country level. As specified in the Call, WROs/networks/coalitions operating at multi-country, sub-regional or regional level in East and Southern Africa are eligible to apply for this call (organizations with programmatic focus on only one country are not eligible).
13	Can a National Consortium be considered for this call if one of the organizations is capable to operate regionally.	WROs/network/coalition operating at multi-country, subregional or regional within East and Southern Africa level are eligible to apply for this call. A national consortium that has the capacity to implement the components at sub-regional or regional level can be included as part of a submission, but the lead organizations should be operating at regional level/ sub-regionals. The framing of the components in the CFP needs to be implemented at a regional level and cannot focus on country-level actions.

22	When organizations apply for funding for multiple components, the speaker mentioned the need to have a separate budget for each component. Clarify how these components should be detailed in the proposal narrative? Specifically, do you expect the narrative to differentiate activities by each component as well?	When partners are working in consortium, UN Women will not sign partner agreements with each consortium member, but there would be one managing the partnership with the other consortium members. We might have 3 to 5 partner agreements with different components.  For example, if an organization is submitting for components 1 and 2, in the narrative and technical proposal, the CSO will indicate, how they plan to implement under the component. This could be the organization implementing itself component 1a or if it will have sub-contractors, and the same for 1b and other components Again, for component 2, CSO will indicate.  For the financial proposal, which needs to be separate, they need to indicate the budget for each component and a consolidated budget for the 2 components.
		It is important to note the maximum budget indicated on page1 of the Call for each component cannot be exceeded for the submission to be considered. It is important to note that technical and financial proposal are reviewed separately.

If the submitting organization will use coalition members as sub-partners or sub-contractors, there will need to be information on
