# HIGHLIGHTS OF THE GEF COMMITMENTS AND PROGRESS: FROM COMMITMENT TO ACTION

# Introduction

- Kenya is co-leading the Generation Equality Forum on GBV Action Coalition.
- The GE Forum was launched in 2021, in Paris and Kenya made 12 concrete commitments to ending all forms of GBV and FGM by 2026.
- The commitments are anchored on key pillars of Financing;
  Leadership and Accountability, Laws and policies; Data; and Service Delivery.
- The Government of Kenya is working in collaboration with all stakeholders to implement the commitments.

## Commitment 1:

**Full implementation of GBV** laws and policies by adopting a GBV indicator in the government performance contracting framework to track duty-bearers accountability on enforcement and implementation of GBV laws and policies by 2022

- Review of National Policy on Prevention of and Response to Gender-Based Violence (GBV) 2014.
- County-specific GBV policies have been developed in 8 counties.
- Dissemination of Protection Against Domestic Violence (PADV) Rules, 2020.
- GBV Indicators in Government
  Performance Contracting.

Invest USD 23 million for GBV prevention and response by 2022 and increase resource allocation to USD 50 million by 2026 through a co-financing model.

- Enhanced Financial Commitment by the Government.
- Bilateral Collaborations.
- Development Partnerships.

Ratify and implement the ILO Convention 190 on eliminating Gender Based Violence and harassment in the world of work by 2026 in close partnership with the private sector.

- The ratification of the ILO Convention 190 process is **on-going**.
- Gender Champion Training on the provisions and significance of ILO Convention 190 by the Central Organization of Trade Unions (COTU).
- Private Sector Gender Mainstreaming
  Policy developed by The Kenya
  Private Sector Alliance (KEPSA).

## Commitment 4:

Introduce a module on GBV in the 2022 Kenya Demographic Health Survey (KDHS) to strengthen the utilization of gender statistics in informing the design, scale-up, and evaluation of FGM and GBV programming.

- Gender-Based Violence module was introduced in the 2022 KDHS with data disaggregated by county.
- Retention and expansion of the FGM module in the 2022 KDHS to cover more indicators.
- Expanded the module on Women Empowerment

Develop a GBV Management and Information System (GBVIMS) by 2022 to strengthen GBV prevention and response programming.

- GBVIMS has been developed by the National Gender and Equality Commission (NGEC).
- The system has a sexual violence module that will be vital in capturing prompt data on GBV.
- The system will be integrated with other information systems that include the District Health management Information System(DHMS).

Invest Kshs.100 million annually for GBV research and innovation to boost evidence-based programming.

- Partnership with academic and other research institutions to conduct in-depth research on GBV and gender-related matters across diverse sectors of development.
- Further Analysis of the 2022 KDHS.

Integrate GBV services (medical, legal, and psychological support services) into the essential minimum package of Universal Health Coverage (UHC) by 2022.

- Existence of Guidelines for the establishment of Gender-Based Violence Recovery Centres (GBVRCs).
- Integrated SGBV Centres like Tumaini clinics within County health facilities in Nairobi.
- The establishment of 12 Specialized Gender-Based Violence (SGBV) courts.

Scale up the National Police Service integrated response to GBV '(Policare)' and establish Gender Based Violence Recovery Centers and shelters in all 47 counties.

- Policare Policy Statement and Procedures developed to lay out a structured approach to addressing gender-based violence within the National Police Service.
- Gazetted Policare Centers: The Office of Inspector General of Police has taken significant steps by officially gazetting Policare centres in Nairobi and Nanyuki
- Plans to expand Policare to additional counties. This expansion strategy prioritizes areas with a high prevalence of GBV, including Samburu, Kilifi, and Bungoma.
- Strengthened gender Desks in selected police stations.
- GBVRCs established in Government Level 5
  Hospitals in counties.

Establish a GBV survivors fund through a co-financing model in partnership with the private sector, civil society, and other stakeholders for the economic empowerment of GBV survivors.

- Jasiri Fund Establishment: A collaborative effort involving CSOs like Collaborative Centre for Gender and Development (CCGD), Mastercard, GROOTS Kenya, and Centre for Rights Education and Awareness (CREAW) being implemented in 10 counties.
- **Dignity Pack Implementation:** To mitigate challenges, the government has introduced the Dignity Pack/Kit initiative.
- Action Aid's Survivor Fund.

GBV prevention and response in crisis situations such as the COVID-19 pandemic response, humanitarian contexts and electoral-related GBV.

- Government allocated a total of Kshs.
  200M to address GBV during COVID-19 pandemic.
- Activation of County GBV and FGM Working Groups during crisis for comprehensive responses to genderbased violence within their respective regions.
- Establishment of an Active GBV Task
  Force to coordinate multifaceted
  responses to GBV issues, thereby
  reinforcing crisis management efforts.

To strengthen collaboration with nonstate actors including girlled, women's rights organizations, male champions, and the private sector through coordination structures such as the gender sector working groups at the national and county levels.

- Strengthening of Gender Sector Working Groups at National and County level.
- Establishment of the male engagement and inclusion in the GSWG
- Localization of Generation Equality Forum (GEF) e.g engagements with elders in mt.elgon and Samburu, anti FGM declarations, capacity building for nyumba kumi and duty bearers at grass root level
- Operationalization of Multi-Agency Technical Committee (M-ATC) to accelerate the elimination of Female Genital Mutilation.
- Establishment of County Anti-FGM Coordination Steering Committees

Adopt and institutionalize a multisectoral GEF Leadership structure to guide the implementation of Kenya's GEF Commitments in the **GBV** Action Coalition up to 2026.

- National Advisory Committee: This committee plays a central role in providing comprehensive guidance for the implementation of GEF initiatives.
- National Steering Committee: This committee spearheads the technical execution of GEF Commitments, ensuring a focused and effective approach.
- Secretariat Support: This support structure aids in coordinating and facilitating the execution of GEF Commitments, contributing to streamlined efforts.
- Strong Linkages with GBV/FGM Committees: The leadership structures established under GEF have forged significant linkages with both the National and County GBV/FGM committees.
