#### **Section 3: Instructions to proponents**

#### 1. Introduction

- 1.1 UNWOMEN invites qualified parties to submit Technical and Financial Proposals to provide services associated with the UN WOMEN requirement for Responsible Party (Non-Governmental Organization, Community Based Organizations(CBOs) and Academic Organizations).
- 1.2 A description of the services required is described in CFP Section 4 -Terms of Reference.
- 1.3 UNWOMEN may, at its discretion, cancel the services in part or in whole.
- 1.4 Proponents may withdraw the proposal after submission, provided that written notice of withdrawal is received by UN WOMEN prior to the deadline prescribed for submission of proposals. No proposal may be modified subsequent to the deadline for submission of proposal. No proposal may be withdrawn in the interval between the deadline for submission of proposals and the expiration of the period of proposal validity.
- 1.5 All proposals shall remain valid and open for acceptance for a period of 90 calendar days after the date specified for receipt of proposals. A proposal valid for a shorter period may be rejected. In exceptional circumstances, UNWOMEN may solicit the proponent's consent to an extension of the period of validity. The request and the responses thereto shall be made in writing.
- 1.6 Effective with the release of this CFP, <u>all</u> communications must be directed only to UNWOMEN Info Somalia, by email at: <u>Somalia.cfp@unwomen.org</u>. Proponents must not communicate with any other personnel of UNWOMEN regarding this CFP.

#### 2. Cost of proposal

The cost of preparing a proposal, attendance at any pre-proposal conference, meetings or oral presentations shall be borne by the proponents, regardless of the conduct or outcome of the CFP process. Proposals must offer the services for the total requirement; proposals offering only part of the services will be rejected.

#### 3. Eligibility

Proponents must meet all mandatory requirements/pre-qualification criteria as set out in Annex B2-2. See <u>paragraph 10 below</u> for further explanation. Proponents will receive a pass/fail rating on this section. To be considered, proponents must meet all the mandatory criteria described in Annex B2-2. UN WOMEN reserves the right to verify any information contained in proponent's response or to request additional information after the proposal is received. Incomplete or inadequate responses, lack of response or misrepresentation in responding to any questions will result in disqualification.

#### 4. Clarification of CFP documents

- 4.1. A prospective proponent requiring any clarification of the CFP documents may notify UNWOMEN in writing at UNWOMEN email address indicated in the CFP by the specified date and time. UNWOMEN will respond in writing to any request for clarification of the CFP documents that it receives by the due date outlined on section 2. Written copies of UNWOMEN response (including an explanation of the query but without identifying the source of inquiry) will be posted using the same method as the original posting of this (CFP) document.
- 4.2. If the CFP has been advertised publicly, the results of any clarification exercise (including an explanation of the query but without identifying the source of inquiry) will be posted on the advertised source.

#### 5. Amendments to CFP documents

- 5.1. At any time prior to the deadline for submission of proposals, UNWOMEN may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective proponent, modify the CFP documents by amendment. All prospective proponents that have received the CFP documents will be notified in writing of all amendments to the CFP documents. For open competitions, all amendments will also be posted on the advertised source.
- 5.2. In order to afford prospective proponents reasonable time in which to take the amendment into account in preparing their proposals, UNWOMEN may, at its discretion, extend the deadline for the submission of proposal.

#### 6. Language of proposal

- 6.1 The proposal prepared by the proponent and all correspondence and documents relating to the proposal exchanged between the proponent and UNWOMEN, shall be written in English.
- 6.2 Supporting documents and printed literature furnished by the proponent may be in another language provided they are accompanied by an appropriate translation of all relevant passages in English. In any such case, for interpretation of the proposal, the translation shall prevail. The sole responsibility for translation and the accuracy thereof shall rest with the proponent.

#### 7. Submission of proposal

7.1. Technical and financial proposals should be submitted as part of the template for proposal submission (Annex B2) in one email. with the CFP reference and the clear description of the proposal by the date and time stipulated in this document. If the emails and email attachments are not marked as instructed, UNWOMEN will assume no responsibility for the misplacement or premature opening of the proposals submitted. The email text body should indicate the name and address of the proponent.

- 7.2 Proposals should be received by the date, time and means of submission stipulated in this CFP. Proponents are responsible for ensuring that UNWOMEN receives their proposal by the due date and time. Proposals received by UNWOMEN after the due date and time may be rejected.
- 7.3 When receiving proposals by email (as is required for the CFP), the receipt time stamp shall be the date and time when the submission has been received in the dedicated UNWOMEN inbox. UNWOMEN shall not be

responsible for any delays caused by network problems, etc. It is the sole responsibility of proponents to ensure that their proposal is received by UNWOMEN in the dedicated inbox on or before the prescribed CFP deadline.

7.4 The "Certificate of Proponent's Eligibility and Authority to Sign Proposal" contained in this CFP must be executed by a representative of the proponent who is duly authorized to execute contracts and bind the proponent. Signature on the certificate represents that the proponent has read this CFP, understands it and agrees to be bound by its terms and conditions. The proponent's proposal with any subsequent modifications and counter-proposals, if applicable, shall become an integral part of any resulting contract.

7.5 **Late proposals:** Any proposals received by UNWOMEN after the deadline for submission of proposals prescribed in this document, may be rejected.

#### 8. Clarification of proposals

To assist in the examination, evaluation and comparison of proposals, UNWOMEN may, at its discretion, ask the proponent for a clarification of its proposal. The request for clarification and the response shall be in writing and no change in the price or substance of the proposal shall be sought, offered or permitted. UNWOMEN will review minor informalities, errors, clerical mistakes, apparent errors in price and missing documents in accordance with the UNWOMEN Policy and Procedures.

#### 9. Proposal currencies

All prices shall be quoted in US Dollars (USD)

UNWOMEN reserves the right to reject any proposals submitted in another currency than the mandatory currency for the proposal stated above. UNWOMEN may accept proposals submitted in another currency than stated above if the proponent confirms during clarification of proposals, see item (8) above in writing, that it will accept a contract issued in the mandatory proposal currency and that for conversion the official United Nations operational rate of exchange of the day of CFP deadline as stated in the CFP letter shall apply.

Regardless of the currency of proposals received, the contract will always be issued and subsequent payments will be made in the mandatory currency for the proposal above.

#### 10. Mandatory/pre-qualification criteria

- 10.1 The mandatory requirements/pre-qualification criteria have been designed to assure that, to the degree possible in the initial phase of the CFP procurement process, only those proponents with sufficient experience, the financial strength and stability, the demonstrable technical knowledge, the evident capacity to satisfy UNWOMEN requirements and superior customer references for supplying the services envisioned in this CFP will qualify for further consideration. UNWOMEN reserves the right to verify any information contained in proponent's response or to request additional information after the proposal is received. Incomplete or inadequate responses, lack of response or misrepresentation in responding to any questions will affect your evaluation.
- 10.2 Proponents will receive a pass/fail rating in the mandatory requirements/pre-qualification criteria section. In order to be considered for Phase I, proponents must meet all the mandatory requirements/pre-qualification criteria described in this CFP.

#### 11. Evaluation of technical and financial proposal

a. PHASE I – TECHNICAL PROPOSAL (70 points)

i. Only proponents meeting the mandatory criteria will advance to the technical evaluation in which maximum possible 70 points may be determined. Technical evaluators who are members of a Committee for Partners' Assessment (CPA) appointed by UNWOMEN will carry out the technical evaluation applying the evaluation criteria and point ratings as listed below. In order to advance beyond Phase I of the detailed evaluation process to Phase II (financial evaluation) a proposal must have achieved a minimum cumulative technical score of 50 points.

#### b. PHASE II - FINANCIAL PROPOSAL (30 points)

Financial proposals will be evaluated following completion of the technical evaluation. The proponent with the lowest evaluated cost will be awarded 30 points. Other financial proposals will receive pro-rated points based on the relationship of the proponents' prices to that of the lowest evaluated cost.

Formula for computing points: Points = (A/B) Financial Points

Example: Proponent A's price is the lowest at \$10.00. Proponent A receives 30 points. Proponent B's price is \$20.00. Proponent B receives  $($10.00/$20.00) \times 30$  points = 15 points

#### 12. Preparation of proposal

- 12.1 You are expected to examine all terms and instructions included in the CFP documents.

  Failure to provide all requested information will be at proponent's own risk and may result in rejection of proponent's proposal.
- 12.2 Proponent's proposal must be organized to follow the format of this CFP. Each proponent must respond to every stated request or requirement and indicate that proponent understands and confirms acceptance of UNWOMEN stated requirements. The proponent should identify any

substantive assumption made in preparing its proposal. The deferral of a response to a question or issue to the contract negotiation stage is not acceptable. Any item not specifically addressed in the proponent's proposal will be deemed as accepted by the proponent. The terms "proponent" and "contractor" refer to those organizations that submit a proposal pursuant to this CFP.

- 12.3 Where the proponent is presented with a requirement or asked to use a specific approach, the proponent must not only state its acceptance, but also describe, where appropriate, how it intends to comply. Failure to provide an answer to an item will be considered an acceptance of the item. Where a descriptive response is requested, failure to provide the same will be viewed as non-responsive.
- 12.4 The terms of reference in this document provides a general overview of the current operation. If the proponent wishes to propose alternatives or equivalents, the proponent must demonstrate that any such proposed change is equivalent or superior to UNWOMEN established requirements. Acceptance of such changes is at the sole discretion of UNWOMEN.
- 12.5 Proposals must offer services for the total requirement, unless otherwise permitted in the CFP document. Proposals offering only part of the services may be rejected unless permitted otherwise in the CFP document.
- 12.6 Proponent's proposal shall include all of the following labelled annexes:

#### 13 Format and signing of proposal

- 13.1 The proposal shall be typed or written in indelible ink and shall be signed by the proponent or a person or persons duly authorized to bind the proponent to the contract. The latter authorization shall be indicated by written power-of-attorney accompanying the proposal.
- 13.2. A proposal shall contain no interlineations, erasures, or overwriting except as necessary to correct errors made by the proponent, in which case such corrections shall be initialled by the person or persons signing the proposal.

#### 14 Award

- 14.1 Award will be made to the responsible and responsive proponent with the highest evaluated proposal following negotiation of an acceptable contract. UNWOMEN reserves the right to conduct negotiations with the proponent regarding the contents of their proposal. The award will be in effect only after acceptance by the selected proponent of the terms and conditions and the terms of reference. The agreement will reflect the name of the proponent whose financials were provided in response to this CFP. Upon execution of agreement UNWOMEN will promptly notify the unsuccessful proponents.
- 14.2 The selected proponent is expected to commence providing services as of the date and time stipulated in this CFP.
- 14.3 The award will be for an agreement with an original term of One year with the option to renew under the same terms and conditions for an additional period or periods as indicated by UNWOMEN.

#### **Section 4: UN Women Terms of Reference**

#### 1. Introduction

#### a. Context Analysis for the required services/results

Grounded in the vision of equality and enshrined in the Charter of the United Nations, UN Women works for the elimin of discrimination against women and girls, empowerment of women, and the achievement of equality between we and men as partners and beneficiaries of development, human rights, humanitarian action and peace and security. Power's rights at the center of all its efforts, UN Women leads and coordinate United Nations system efforts to extend that commitments on gender equality and gender mainstreaming translate into action throughout the world. It prostrong and coherent leadership in support of national priorities and efforts, building effective partnerships government, civil society and other relevant actors.

Globally, women representation in leadership and governance remain low. Women representation in parliamed currently at 23.8% (IPU 2017). This is despite an increase in campaigns and advocacy for women's inclusion in govern coupled with increased numbers of women running for elective positions, improved policy, legislative and environments within which women are running for elective offices. In Africa the leading countries on women problem include Rwanda 64% which is leading globally, Senegal 42.7%, South Africa 42%, and Namibia 41.3%. In Africa region, Rwanda 64%, Tanzania 36%, Uganda 35% and Burundi 30.5% are the leading countries.

Somali women were significantly under-represented in public life and decision-making processes; including electron processes and public service. Women's representation in the parliament has just increased from 14% in 2012 to 2016 (the eighth legislature). It is being realized that this increase is because of the CSOs 30% women's representation advocacy efforts made during election campaigns, particularly the Goodwill Ambassadors' tireless work. There supporting women CSOs' advocacy is becoming crucial and necessary for better representation of women in december.

There are several global and regional instruments that inform the pursuit of gender equality and empowerment in At the global level, the Sustainable Development Goals, and the underpinning Agenda 2030, recognize that the reali of gender equality is a pre-requisite for the achievement of economic, environmental and social development. According to Agenda 2030, it is a fundamental human right for women and girls to enjoy equal access to quality education, eco resources and political participation as well as equal opportunities with men and boys for employment, leadershid decision-making at all levels. SDG 5 is on "Achieving Gender Equality and Empower All Women and Girls', in addit cross-cutting gender issues in all the 17 goals, which implies that gender equality is central in the achievement of SDG goals. Prior to the SDGs, the UN agreed a Minimum Set of 52 quantitative Gender Indicators that all countries a produce, some of which are part of the SDGs.

There are other international agreements on gender equality and empowerment that also have great significant women participation in decision making: The Convention on the Elimination of All Forms of Discrimination Against Worthe International Covenant on Civil and Political Rights, the Beijing Platform for Action (1995), the African Charter on Frand People's Rights and the Rights of Women in Africa (Maputo Protocol, 2003), the Solemn Declaration on Gender Edin Africa (2004), among others are included.

#### b. Background Information

The Joint UN Programme on Women's Political Leadership, Participation and Empowerment (JP WPE) is a collaboration initiative between the Federal Government, represented by the Ministry of Women and Human Rights Develop (MoWHRD) and the UN, represented by the UNDP, UN Women, and UNSOM with the goal of 'strengthening wo leadership and participation in decision-making processes and structures in Somalia; making them more inclusive gender responsive'. The JP WPE is a multi-year initiative aiming at promoting transformational change for gender expenses.

and women's political empowerment. Running from 2016-2020, the programme is so far funded by DFID through Multi-Partner Trust Fund Modality (MPTF) established under the Somali Development and Reconstruction Facility (S

The implementation of JP WPE over four years will require US\$ 6,818,784.00 of which GBP 3,700,000.00 representation (USD 4,800,908.00) is funded by DFID. 29.60% of the budget is unfunded.

Under the overall leadership of and in collaboration with the Ministry of Women and Human Rights Develop (MoWHRD), the Joint Programme on Women Political Leadership and Empowerment (JP WPE) brings together strinterventions implemented and supported by UNDP, UN Women and UNSOM to enable a coherent and consoli approach toward increasing the participation and strengthening the role of women in the peacebuilding and state-buprocesses; focusing on their leadership and empowerment within three key areas: (1) adoption of gender respected legal, policy and planning frameworks, (2) increased voice and recognition of women as leaders and decreased and makers, and (3) enhanced coordination capacities of gender ministries at federal and member state levels.

Cultural and attitudinal barriers, limited endowments of women and girls (in terms of health, education and assets social norms about gender roles limit also women's participation. Therefore, a multi-pronged approach and strateg concerted efforts and initiatives are required to address all these constraints, including working with women CS promote special representation measures for Somali women voices in 2020 elections.

The four-year period between 2016 and the 2020 electoral cycle will be a period of significant opportunities for strengthening of women's civil society organizations to advocate for women's representation in leadership participation in decision-making at all levels through establishment of national women forums and structures (su national women's representation task force), influencing electoral legal frameworks to be gender responsive and generated and development of national action plan and strategy for women's equal participation in 2020 elections.

#### c. Justification

Somalia has faced almost three decades of internal conflict, extreme poverty and under-development, food insecurit massive internal displacement of the populations. The protracted war in Somalia has severely impacted on a majo the population and significantly so on women and girls. Women have not been adequately included in formal politic state building processes since peace building and negotiations have tended to follow a clan-based approach. The c power-sharing arrangements following the clan based 4.5 formula does not allow for Somali women's enh participation unless specific measures are taken.

However, significant political developments were reached recently, although there are much to be done on the cou constitutional review, to achieve the inclusive politics in 2020, the Government has developed an agenda: 'Roadmap which has three main components: (i) Democratization, (ii) Finalizing the Constitution, and (iii) Decentralization person one vote' is also sought to be applied in 2020 elections. Over the coming three years, Somalia plans to conscits democratization agenda through, among others, a sound system of political representation and a participatory applies affairs aiming to increase people participation in state affairs. The democratic agenda aims to introduce multidemocracy by 2020, through: (i) Enactment of Political Parties Law. (ii) Development of an Electoral Law. (iii) Regist of political parties and most importantly finalization of the constitution with national public referendum.

All these processes will culminate in the establishment of permanent federal institutions and installation of e Parliamentarians and President of the Federal Republic of Somalia in 2020. Therefore, women CSOs have an improle to play in these processes of electoral legal framework development, political parties development and w political aspirants preparations which could provide an opportunity for Somali women to create a new reality for wo political participation and leadership in 2020 Somalia elections.

## UN Women Key Result Area: Women participate and benefit from peacebuilding, security and recogning

This result area is responding and contributing to Outcome 4.3 of UN Women country Strategic Note (The socio-eco recovery & political participation of women and girls are promoted in the fragile context); UN Women Africa Str

Outcome 1: (Women lead, participate in and benefit equally from decision making processes); and UN Women of Strategic Priority 1: (Women lead, participate in and benefit equally from governance systems). It is also aligned with Strategic Priority one (1) of the UN Strategic Framework for Somalia (Deepening federalism and state-building, supposed conflict resolution and reconciliation, and preparing for universal elections) and Somalia National Development Plan – 2019) pillar one (1): (Peace, security and rule of Law).

UN Women Somalia has selected one flagship program area: Women's Engagement in Peace, Security, and Reconstruction of Commitments will be addressed under this flagship: 1) An enabling environment for implementation of Commitments is created; 3) Women and girls' safety, physical and mental health and security are assured and their has respected; and 4) The socio-economic recovery & political participation of women and girls are promoted fragile context. This later outcome has three outputs among which: "Women participate and benefit from peacebus security and recovery planning" is among them.

To ensure achievement of results on the flagship area, UN Women will empower civil society organizations to advocate development and implementation of national action plans for UNSCR 1325 and build capacities of women to participand influence decisions and legal framework development processes including constitutional development, election development, political parties review and other related polices, arrangements and political development.

Based on the principles of the New Deal Compact, UN Strategic Framework for Somalia and the Somalia National Development, and under the leadership of the Ministry of Women and Human Rights Development, a Joint Program Women Political Empowerment is being implemented jointly by UNDP, UN Women and UNSOM. This JP that falls the current framework of UNSF strategic priority one: Deepening federalism and state-building, supporting constitution and reconciliation, and preparing for universal elections and Somalia National Development Plan (2017 – pillar one (1): Peace, security and rule of Law. This JP addresses the above-mentioned women's equal participated constitution and focuses on eight output areas under three outcomes as follows:

Outcome 1: Key and enabling legislations and policies are reformed/adopted to promote Gender Equality and wo political participation:

- Output 1.1: Revised Federal Constitution of Somalia, political parties' law; electoral law adopted; enabling incr women political participation;
- Output 1.2: Strengthened capacity of NIEC, ICRIC, MOIFA, MOCA and Parliament to enhance women's per participation and leadership at federal and state level;
- Output 1.3: Political party policies and procedures reformed to include and increase women participation in decision-making structures;
- Output 1.4: Violence against women in political, state formation, peace building and elections are mitigated.

Outcome 2: increased voice and recognition of women as leaders and decision-makers:

- -Output 2.1: increased voice of women and their networks and coalition within formal and informal decision-n structures at federal, state, district and communities level;
- -Output 2.2. Leadership capacity and educing skills of women in decision-making positions and women aspiran candidates to elections are strengthened (MPs, women councillors, Ministers and Gender Advisors, political asp candidates etc.).

Outcome 3: Enhanced capacity of MoWHRD and Ministries of Women in Somaliland and Puntland to coordinat advocate for increasing women participation and gender equality in political and electoral processes:

- -Output 3.1: Strengthened capacities of Ministries of women (FGS, Puntland and Somaliland) to influence leg policy environment promoting and increasing women political participation at federal and state levels a coordinate with the key institutions and partners engaged in political and electoral processes;
